<u>Missing Endangered Adult—Town of Burke</u>

The Dane County Sheriff's Office is asking for the public's assistance in locating 62 year-old Paul H. Ferrall of Madison, Wisconsin. He was last seen on Friday, July 19, 2024 in the area of Larry Lane in the Town of Burke and left the area on foot. Mr. Ferrall has no access to a vehicle and was recently in the downtown Madison area.

Mr. Ferrall is a white male, approximately 5'11" and 165lbs and was last seen wearing blue jeans and a multi-colored sweater.
